

Release and Waiver of Liability

Please Read Carefully! This is a legal document that affects your legal rights.

The Volunteer desires to work as a Volunteer for Tucker's House and engage in the activities related to being a volunteer (the "Activities"). The Volunteer understands that the Activities may include constructing and rehabilitating residential buildings, working in the Tucker's House offices, and living in housing provided for volunteers of Tucker's House.

The Volunteer hereby freely, voluntarily, and without duress executes this Release under the following terms:

RELEASE AND WAIVER. Volunteer does hereby release and forever discharge and hold harmless Tucker's House and its successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from Volunteer's Activities with Tucker's House. Volunteer understands that this Release discharges Tucker's House from any liability or claim that the Volunteer may have against Tucker's House with respect to any bodily injury, personal injury, illness, death, or property damage that may result from Volunteer's Activities with Tucker's House, whether caused by the negligence of Tucker's House or its officers, directors, employees, or agents or otherwise. Volunteer also understands that Tucker's House does not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health, or disability insurance in the event of injury or illness.

MEDICAL TREATMENT. Volunteer does hereby release and forever discharge Tucker's House from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with the Volunteer's Activities with Tucker's House.

ASSUMPTION OF THE RISK. The Volunteer understands that the Activities include work that may be hazardous to the Volunteer, including, but not limited to, construction, loading and unloading, and transportation to and from the work sites. Volunteer hereby expressly and specifically assumes the risk of injury or harm in the Activities and releases Tucker's House from all liability for injury, illness, death, or property damage resulting from the Activities.

INSURANCE. The Volunteer understands that, except as otherwise agreed to by Tucker's House in writing; Tucker's House does not carry or maintain health, medical, or disability insurance

coverage for any volunteer. Each Volunteer is expected and encouraged to obtain his or her own medical or health insurance coverage.
