



Release and Waiver of Liability

Please Read Carefully! This is a legal document that affects your legal rights.

This Release and waiver of Liability (the "Release") executed on this _____ day of _____, 20____ by _____ (the "Volunteer") in favor of Tucker's House, a Tennessee nonprofit corporation, its directors, officers, employees, and agents collectively, "Tucker's House").

The Volunteer desires to work as a Volunteer for Tucker's House and engage in the activities related to being a volunteer (the "Activities"). The Volunteer understands that the Activities may include constructing and rehabilitating residential buildings, working in the Tucker's House offices, and living in housing provided for volunteers of Tucker's House.

The Volunteer hereby freely, voluntarily, and without duress executes this Release under the following terms:

RELEASE AND WAIVER. Volunteer does hereby release and forever discharge and hold harmless Tucker's House and its successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from Volunteer's Activities with Tucker's House. Volunteer understands that this Release discharges Tucker's House from any liability or claim that the Volunteer may have against Tucker's House with respect to any bodily injury, personal injury, illness, death, or property damage that may result from Volunteer's Activities with Tucker's House, whether caused by the negligence of Tucker's House or its officers, directors, employees, or agents or otherwise. Volunteer also understands that Tucker's House does not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health, or disability insurance in the event of injury or illness.

MEDICAL TREATMENT. Volunteer does hereby release and forever discharge Tucker's House from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with the Volunteer's Activities with Tucker's House.

ASSUMPTION OF THE RISK. The Volunteer understands that the Activities include work that may be hazardous to the Volunteer, including, but not limited to, construction, loading and unloading, and transportation to and from the work sites. Volunteer hereby expressly and specifically assumes the risk of injury or harm in the Activities and releases Tucker's House from all liability for injury, illness, death, or property damage resulting from the Activities.

INSURANCE. The Volunteer understands that, except as otherwise agreed to by Tucker's House in writing; Tucker's House does not carry or maintain health, medical, or disability insurance coverage for any volunteer. Each Volunteer is expected and encouraged to obtain his or her own medical or health insurance coverage.

PHOTOGRAPHIC RELEASE. The Volunteer does hereby grant and convey unto Tucker's House all right, title, and interest in any and all photographic images and video or audio recordings made by Tucker's House during the Volunteer's Activities with Tucker's House, including, but not limited to, any royalties, proceeds, or other benefits derived from such photographs or recordings.

MEDIA WAIVER RELEASE: I give consent for me or my child(ren) photos and videos used to promote and raise funds for Tucker's House. I understand that the images and videos may be used in print publications, online publications, presentations, websites, and social media. I also understand that no royalty, fee or other compensation shall become payable to me because of such use. (PLEASE INITIAL BELOW)

The Volunteer expressly agrees that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Tennessee, and that this Release shall be governed by and interpreted in accordance with the laws of The State of Tennessee. The Volunteer agrees that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable.
